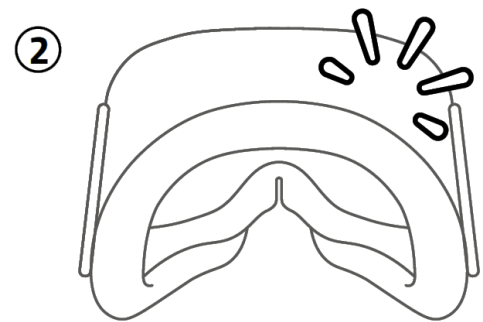
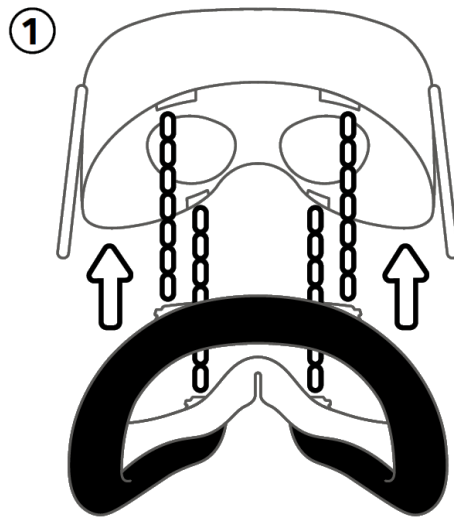

5. SAFETY AND MAINTENANCE

SAFETY GUIDELINES

- Do not expose the product to fine solid objects such as dust, dirt, and sand.
- Do not expose the product to open flames such as stoves, candles, or fireplaces.

MAINTENANCE AND USE

- Regularly sanitize the facial interface with a damp soft cloth or use alcohol-free.
- antibacterial wipes to prevent dirt buildup and avoid skin irritation.
- Make sure you wipe clean the facial interface both from outside (silicone cushion) and inside surfaces (plastic molding). Do not wash or soak the facial interface.
- Keep your face clean and dry when wearing using the facial interface to avoid deteriorating the quality of the foam cushions.
- Store facial interface in their original packaging or storage case when not in use to minimize unintentional damage or environment exposure.
- Handle with care. Do not drop or bend the facial interface.
